

**Official Raffle Rules,
Raffle Drawing November 7, 2020
Barbados Association of Southern California hereinafter referred to throughout this document as
BASC**

By entering this raffle, entrants accept and agree to (1) to be bound by all the rules, limitations and restrictions set forth herein and (2) that their names and/or likeness may be disclosed to and used by **BASC** and may otherwise be used by **BASC** for publicity purposes and in lists of prize winners to be published in area newspapers and/or announced on the **BASC** website. Other rules and regulations may apply. Please contact **BASC** if you have questions. **BASC's** interpretation and application of the rules and regulations shall be final.

By entering this raffle, each participant releases **BASC**, its directors, officers, members and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the raffle or winning any prize or resulting from acceptances, possession, use or misuse of any prize, and each winner agrees to indemnify and hold **BASC** harmless from any and all losses, damages, rights, claims and actions of any kind rising in connection with or as a result of participating in the raffle or the winner's acceptance or use of any prize.

Further, each participant hereby waives the provisions of civil code section 1542 which states the following: ***"A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."***

Certain prize winners, including but not limited to the First Prize Winner, will be required to sign a written agreement confirming the above-described release and a waiver as a condition to receiving such prize(s).

PRIZES , ALSO REFERRED TO AS AWARDS

The first prize of the BASC 2020 Raffle shall be a Chevrolet Cruze LT, up to \$20,000 and shall be subject to the rules herein, regarding the number of tickets sold. If fewer than 4000 tickets are sold by 8:00pm on November 7th, 2020 the raffle shall be drawn as scheduled and all prizes awarded as advertised with the exception that the First Prize shall become a cash award of 50% of the net proceeds, not to exceed **\$9,990.00**. Net Raffle Proceeds will be calculated based on **BASC** accounting, which shall be final and conclusive with respect to the First Prize Winner. For these purposes, "Net Raffle Proceeds" are defined as the balance of funds left after paying all other prizes, all raffle expenses and all expenses for the House.

The Winner shall be responsible for any cost, taxes, and fees beyond \$20,000.00

Other prizes shall include, but are not limited to:

- **a 7-Day cruise leaving Puerto Rico on December 12th, 2020, making a stop in Barbados. Airfare is not included.**
- **a 3-Day cruise for two (2) from Long Beach, CA, limited to \$600.00. Airfare is not included.**
- **A weekend Getaway at the Marriott Newport Beach Villas limited to \$700.00.**
- **Two tickets to a Los Angeles Rams regular 2020 season game at the SOFI stadium in Inglewood, CA.**
- **Other prizes shall be added as they become available.**

DATE OF DRAWING

- The Raffle shall conclude and winning tickets to be drawn at the **2020 “A Taste of Barbados” November 7th, 2020**. The winning tickets shall be announced at 10.00pm.
- The results with the winning tickets shall be posted to **BASC** website (bascofla.org) within 24 hours.

ODDS

- As many of 6,000 tickets may be sold. However, if fewer than 4,000 tickets are sold by 8:00pm on November 7th, 2020, the raffle shall be drawn as scheduled and all prizes awarded as advertised with the exception that the First Prize shall become a cash award of 50% of the net proceeds, not to exceed \$9,990.00.
- Net Raffle Proceeds will be calculated based on **BASC** accounting, which shall be final and conclusive with respect to the First Prize Winner. For these purposes, “Net Raffle Proceeds” are defined as the balance of funds left after paying all other prizes, all raffle expenses and all expenses for the House.

TICKETS, ENTRIES AND PARTICIPANTS

- Any member of the public may enter the raffle for **\$10.00** per ticket and may enter as often as they wish. There shall be no complimentary tickets; all entries must be paid.
- Any member of the public, including **BASC** members may purchase tickets; however, the Board and Raffle Committee members shall not be eligible to enter, in order to avoid any appearance of conflict of interest.
- Ticket sellers may enter the raffle in as much as all tickets are treated equally and provided the Raffle Committee certifies the entries. However, sellers are encouraged to purchase their tickets from other sellers in order to avoid any appearance of conflict of interest.

A Raffle participant’s sole and exclusive remedy for BASC’s breach shall be limited to the return of the purchase price paid for his or her Raffle Ticket(s). In no event shall BASC, its Directors, Officers, Members, Agents or Representatives be liable to any party for any loss or injuries to earnings, profits or goodwill, or for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages.

WINNERS

- Notwithstanding that some tickets may be paid for and gifted to others, the person whose name is on a winning ticket shall be the one and only winner.
- Winners need not be present to win.
- Winners have 30 days to claim their winning awards; after 30 days the unclaimed awards become the property of **BASC**; however, **BASC** shall make every effort to cause the awards to be received by the respective winners.
- Winners are expected to present their tickets to claim their prizes, however, if a winner is unable to present their ticket, **BASC** shall honor the drawn ticket so long as the person claiming the prize can be properly identified. The ticket-seller shall be engaged in this process.

SELLERS

- Ticket-sellers may be any member of **BASC**. Sellers may also be those trusted, proven members of the community who are known to **BASC**, having established a proven relationship with their goodwill and support of the organization, at the Board's discretion.
- Ticket-sellers shall maintain adequate records of tickets sold, recording the seller's name on the ticket as indicated; all care should be taken to safeguard both monies and tickets, and report immediately to the Raffle Chairman any irregularities in accounting or loss.

RAFFLE COMMITTEE

- A Raffle Committee comprising of no less than three (3) persons shall be appointed by the Board to ensure that all tickets are validated, accounted for, and in good order; and that all prizes are available, their order in the drawing established, and that prizes are delivered as promised.
- The Board retains ultimate responsibility for the integrity of the raffle.

PROCESS

- The raffle shall be certified by the Raffle Committee Chairman.
- There is a distinction between the drawing of the winning tickets, and the announcement of the winning tickets due to the number of prizes, and time considerations.
- **The First Prize (2020 Chevrolet Cruze LT, or alternative \$9,990.00) shall be awarded to the first ticket drawn**, followed by the other top six prizes. However, said tickets may be sequestered in clearly marked, sealed and doubled signature envelopes by the drawer and the president or Raffle Committee Chairman, kept securely, and announced at 10:00pm in reverse order, the winning ticket for the First Prize being announced last.

PROCEEDS

Net proceeds from the raffle shall accrue to **BASC**, a 501(c)(3) organization, to help in furthering its mission.
